1. Information We Collect

A. Personal Information You Provide

When you register for a pilgrimage, join an email list, request information, or contact us, we may collect:

- Name
- Email address
- Phone number
- Mailing address
- Passport information (for travel booking purposes)
- Date of birth (required by airlines/hotels)
- Payment information (processed securely through third-party providers; we do not store full credit card numbers)
- Emergency contact details
- Special requests such as mobility needs or room preferences

B. Automatically Collected Information

When you visit our website, we may automatically collect:

- IP address
- Browser type and operating system

- Pages visited and time spent on the site
- Cookies and similar tracking technologies

Cookies are used to improve your browsing experience and analyze website performance.

2. How We Use Your Information

We use your information to:

- Process registration for pilgrimages
- Communicate pilgrimage updates, confirmations, and reminders
- Book travel components (airline tickets, hotels, transportation, guides, etc.)
- Respond to questions or customer service requests
- Send marketing emails or newsletters (you may unsubscribe at any time)
- Improve our website, services, and communication

We do **not** sell your personal information.

3. Social Media & Reviews

Pilgrims on tour may be photographed for the promotional purposes for AMDG Travel. In addition, any online comments published or submitted by Pilgrims as a review or within one's own social media posts, as well as pictures shared with AMDG Travel, may be used for AMDG Travel's promotional purposes.

4. How We Share Your Information

We may share necessary personal information with:

- Airlines
- Hotels and accommodations
- Motorcoach companies
- Local guides and pilgrimage partners
- Travel insurance providers (if applicable)
- Payment processors (e.g., Stripe)
- Other vendors essential to operating your pilgrimage

All third-party partners receive only the information required to perform their services.

We may also disclose information:

- To comply with legal obligations
 - To protect our rights or investigate suspected fraud
 - With your consent

5. Payment Processing

Payments for pilgrimages are processed through secure third-party payment services such as Stripe.

AMDG Travel, LLC **does not store** your full credit card information on our servers.

6. International Data Transfers

Because our pilgrimages operate internationally, some information may be shared with partners outside the United States.

These transfers are made only as necessary to fulfill your pilgrimage services.

7. Data Retention

We retain personal information only as long as necessary to:

- Operate your pilgrimage
- Maintain transaction records
- Comply with legal, tax, or accounting obligations

Passport information and other sensitive data are deleted once no longer required for travel.

8. Your Rights

Depending on your jurisdiction, you may have the right to:

- Access the personal information we hold
- Update or correct inaccurate information
- Request deletion of your information
- Opt out of marketing communications
- Withdraw consent when applicable
